

NOTICE TO ALL CLASS C WATER AND SEWER COMPANIES

As you are aware, Class C Water and Sewer companies are no longer regulated by the Arkansas Public Service Commission (APSC) pursuant to Act 37 of the First Extraordinary Session of 1987 of the Arkansas General Assembly. However, these companies may fall under APSC jurisdiction if they achieve annual operating revenues exceeding \$150,000 for three consecutive years.

In order for the APSC to monitor the revenues of the Class C Water and Sewer companies, we are requesting that you complete the attached Gross Revenues Form and return it by **March 31** to:
