ORDER

On August 7, 2013, Barbara and Tom Reinsvold ("Reinsvold Intervenors") filed in the above-styled docket a *Motion to Remove Routes 62, 86, and 91 from the List of Considered Routes*. The Reinsvold Intervenors contend Routes 62, 86, and 91 proposed by Southwestern Electric Power Company ("SWEPCO") in this docket will be required to cross property owned by the United States Army Corps of Engineers ("Corps of Engineers") and the Corps of Engineers has advised that it will not make the land available for crossing at the locations proposed by SWEPCO. The Reinsvold Intervenors also contend "the General Staff of the Commission has already determined that route 33 is reasonable route." Given these facts, the Reinsvold Intervenors argue Routes 62, 86, and 91 should be removed from consideration in this docket.

On August 9, 2013, SWEPCO filed a response to the Reinsvold Motion stating it has no objection to the removal of Routes 62, 86 and 91 from further consideration at the evidentiary hearing. SWEPCO further requests an Order declaring Routes 62, 86,




